## ACT NEIGHBOURHOOD WATCH

This community crime prevention program promotes safety, security and well-being, resulting in more caring neighbourhoods. The program is also aimed at reducing crime, especially property crime and crime to the person. ACTNHW encourages residents to look out for neighbours, especially the vulnerable.

Reid has always had a strong sense of neighbourly looking out for each other's safety and home security. As the city grows around us, working together and actively preventing potential crime will become more important.

The RRA Committee is working in cooperation with ACTNHW and encourages all Reid households to join the program. Members are provided with helpful advice on home security, home contents' invisible marking pens and large wheelie bin stickers to deter would be burglars and much more. ## REPRESENTATIONS TO GOVERNMENT

### Reid Oval

The Committee has made representations to the Government regarding what appears to be unregulated all-day commuter parking under the trees surrounding Reid Oval, resulting in soil compaction and damage to the trees.

Unfortunately correspondence received from the Government demonstrates that they are completely unaware of what actually happens, advising us: 'All day parking is not permitted as there is a two-hour limit which discourages people working in the city using this area.' It would be good to see this properly enforced.

We are also informed: 'While parking under the canopy of any tree is not ideal, it is not considered feasible for Transport Canberra and City Services (TCCS) to install bollards in this area.'

The Committee is attempting to meet with the Government to discuss this issue and the unsightly, often graffitied, shipping container.

## TREES

Please be aware that there is a legal process to be undertaken if you are carrying out renovations (plumbing, landscaping etc. requiring root trimming) as such activities have the potential to damage trees on government land i.e. the nature strip or verge. ### MR FLUFFY BLOCKS IN REID

The ACT Government has listed all Mr Fluffy affected premises in Canberra and these are identified by unit and block. Street addresses have also been provided. The complete list can be viewed at [www.asbestostaskforce.act.gov.au/the-list/the-list](http://www.asbestostaskforce.act.gov.au/the-list/the-list)

To redress some erroneous advertising it is important to know there are only three affected premises in Reid. The table below provides the details.

\*These blocks are currently vacant.

\*\*The house on this property has been rebuilt.

Please note, it is vitally important that the heritage values of the streetscapes and built form in the Reid Housing Precinct be maintained as it epitomises the Garden City (UK) or City Beautiful (USA) movements of the C20th. Accordingly, this area has been assessed to have such high values that it has been entered into the ACT Heritage Register [www.environment.act.gov.au/data/assets/pdf\\_file/0010/148474/462.pdf](http://www.environment.act.gov.au/data/assets/pdf_file/0010/148474/462.pdf)

It is up to us all to uphold the Specific Requirements for the Conservation of the Precinct (Entry to the ACT Heritage Register, *Heritage Act 2004*, pp. 8–22). It is most unfortunate when owners and government do not adhere to these values as it diminishes the aesthetics and remarkable uniformity of the precinct. This is ultimately what makes Reid such a distinctive place.

Owners living on either side of 72 Coranderrk Street and 23 Dirrawan Gardens are strongly advised to check development applications (DAs) for any proposed rebuild on those vacant blocks. ### NEWS FROM ST JOHN'S

When did you last visit St John's precinct? There are so many gems in our corner of Reid. The Prophetic Tombstone is one:

On 8 November 1845, thirty-three year old Sarah Webb tragically died during childbirth. During her lifetime she was a pioneer in the Canberra region, but it was her death that catapulted her to fame. She was buried at the newly consecrated St John's Church and churchyard. Her headstone reads 'For here we have no continuing city but seek one to come', a slightly inexact quote of Hebrews 13:14, where the biblical passage refers to a heavenly city hoped for by believers.

Within a few decades after Sarah's death it became apparent that the Limestone Plains was going to be the site of the future national capital. The quote on Sarah's headstone started attracting notice with many taking the passage to be a strange and coincidental prophecy of the coming city of Canberra.

### VALE RHODANTHE GRACE LIPSETT OAM RN RM

Dr (Hon) Rhodanthe Lipsett was a most remarkable woman. She received an OAM in 1992 for her lifelong work with mothers and babies and in 1996, she was made a Fellow of the Australian College of Midwives in recognition of her work in the profession. Ten years later Australian College of Midwives created the *Rhodanthe Lipsett Award* in recognition of her work.

In 2012, Rhodanthe received an honorary doctorate from the University of Canberra for her lifetime service to baby and maternal health including the publication in 2004 of *No One Right Way*. The revised edition, titled *Baby Care: Nurturing your baby your way*, was launched in 2012 by the then Governor-General, Ms Quentin Bryce AC CVO. Royalties from book sales go to the Rhodanthe Lipsett Indigenous Midwifery Charitable Fund, a fund Rhodanthe established to help Aboriginal and Torres Strait Islander women study to become midwives.

Rhodanthe was born on 21 January 1922, raised in South Australia and lived in Reid, Canberra for over 60 years until she died peacefully at home on 17 January 2019. For the many people assembled at St John's Church Hall, Reid on 17 February 2019 it was a privilege to hear the warm and treasured memories and extraordinary contribution Rhodanthe made over her lifetime to the welfare of babies and mothers.
